

Glossary of Emission Coverage

BMW New Vehicle Limited Warranty

All emissions relevant components or systems are covered under the New Vehicle Limited Warranty against defect in product or workmanship for a period of **4 years or 50,000 miles**, whichever occurs first.

Federal Emission Warranties

- **General**

All emissions relevant components or systems are covered under the Federal Emission General Warranty against defect in product or workmanship for a period of **2 years or 24,000 miles**, whichever occurs first.

Because the BMW New Vehicle Limited Warranty coverage exceeds the Federal Emission General Warranty, repairs would be claimed under the New Vehicle Limited Warranty.

- **Specific Component**

Specific Emission Related components are covered under the Federal Emission Warranty against defect in product or workmanship for a period of **8 years or 80,000 miles**, whichever occurs first.

This is limited to the catalytic converters and the engine control module (including on-board diagnostic system).

California Emission Control System Limited Warranties

- **Short-Term Emission Warranty Coverage**

All emissions relevant components or systems on all models are covered under the California Emission Control Warranty against defect in product or workmanship for a period of **3 years or 50,000 miles**, whichever occurs first.

Because the BMW New Vehicle Limited Warranty coverage exceeds the General Emission Warranty Coverage, repairs would be claimed under the New Vehicle Limited Warranty.

- **Long-Term Emission Control Defects Warranty**

Specific Emission Related components are covered under the California Emission Control Warranty against defect in product or workmanship for a period of **7 years or 70,000 miles**, whichever occurs first.

Only high cost emission control components are covered by this warranty. The cost threshold is determined by the California Air Resource Board (CARB).

A complete list of the covered components for specific models can be found in the specific vehicles' Service and Warranty Booklet.

This coverage applies to the specific model, for the model year in the specific state where it was first retailed or is currently registered. The states affected by this specific coverage are:

- California, Maine, Massachusetts, and Vermont from 2003 Model Year
- Connecticut and Rhode Island from 2008 Model Year
- New Jersey, Oregon, Pennsylvania, and Washington from 2009 Model Year

- **Long-Term Emission Control Defects Warranty with Optional Certification**

In order to earn additional California Air Resource Board (CARB) fleet average emissions credits, a manufacturer may pursue an optional certification for specific models. This extends the Long-Term Emission Control Defects Warranty.

Specific Emission Related components covered under the optional Certification are warranted against defect in product or workmanship for a period of **8 years or 100,000 miles**, whichever occurs first.

A complete list of the covered components for specific models can be found in the specific vehicles' Service and Warranty Booklet.

This coverage applies to the specific model, for the model year in the specific state where it was first retailed or is currently registered. The states affected by this specific coverage are:

- California, Maine, Massachusetts, and Vermont from 2003 Model Year
- Connecticut and Rhode Island from 2008 Model Year
- New Jersey, Oregon, Pennsylvania, and Washington from 2009 Model Year

- Super Ultra Low Emission Vehicle (SULEV) classified as Partial Zero Emission Vehicle (PZEV)

for States that Have Partially Adopted the California Air Resource Board Statutes

All emissions relevant components or systems are covered under the California Emission Control Warranty against defect in product or workmanship for a period of **3 years or 50,000 miles** for all parts and **7 years or 70,000 miles** for high cost parts on the list in the Service and Warranty Booklets.

This coverage applies to the specific model, for the model year in the specific state where it was first retailed or is currently registered. The states affected by this specific coverage are:

- Washington from 2009 Model Year
- Oregon from 2009 Model Year
- Pennsylvania from 2011 Model Year

- Super Ultra Low Emission Vehicle (SULEV) classified as Partial Zero Emission Vehicle (PZEV)

for States that Have Fully Adopted the California Air Resource Board Statutes

All emissions relevant components or systems are covered under the California Emission Control Warranty against defect in product or workmanship for a period of **15 years or 150,000 miles**, whichever occurs first.

This coverage applies to the specific model and model year based on the specific state where it was first retailed or is currently registered. The states affected by this specific coverage are:

- California, Maine, Massachusetts, New York and Vermont from 2003 Model Year
- Connecticut and Rhode Island from 2007 Model Year
- New Jersey from 2008 Model Year
- Pennsylvania only 2009 & 2010 Model Years
- Maryland from 2011 Model Year
- New Mexico only 2011 Model Year
